Vendors will be responsible for collecting, filing all applicable sales taxes (8.25%), and displaying tax documents. Vendors that do not, must qualify as exempt according to Texas tax laws, such as occasional sales exemption.

Food vendors are responsible for and should display all required food service licenses as required by Texas law for their items or know that they are exempt under Texas law.

Vendors are also responsible for knowing about /providing any permits /insurance, etc. they may need for their particular booth.

Vendors are requested to stay from at a minimum from 9 AM until 5 PM on Saturday and 11 AM till 5 PM on Sunday.

You may stay later until the park closes if you wish. There is no penalty for not staying the entire time, but it is preferred as to make the most of the day.

Vendors must provide their own set up, take down, and clean up. No tables or tents are provided. There will be plenty of shade in the park, but tents/canopies are still recommended.

Security will be on site, but vendors are responsible for securing their property. The San Saba County Chamber of Commerce, the City of San Saba, and all other entities involved in the production of this event are not responsible for lost property.

Vendor spaces will be assigned as to distribute different types of items, throughout the park based on need, and description of booth.

All locations should get a similar amount of foot traffic. However, those who return forms with payment first will be given preference in event of special needs or placement requests, etc.

You will be notified of your location closer to event time after we close the event to New Vendor entries.
